The \$500.00 Special Assessment for the Security Cameras will be added to 2025's Assessment Bill. Cameras should be up and running by summer.

The cost for the new trash cans will be \$163,000.00 (60 cans). Paul suggested that the mall merchants contribute to the cost of the trash cans in 2026 by means of Special Assessment.

The City will be meeting about the recycling ordinance in February.

Social Media: Continuing to collect orders for bricks

For <u>WashingtonStreetMall.com</u> there were 76,000 page views in November & December. 92% of them were first time visits. 47% of the visits came from Google. This is an increase from last year. The top visits were from Philadelphia Metro area, New York City area, North Jersey, South Jersey, Cherry Hill, Mount Laurel, and Washington DC area.

Looking at social media, Facebook, had over 854,000 views of the content that was posted in November and December, and we reached over 328,000 different accounts.

Instagram had over 198,000 views of the content.
